**City of Chicago
Surplus Equipment Public Auction Affidavit**

Section A: Definitions

"Employee of the City of Chicago" means an individual employed by the City of Chicago, whether part-time or full-time, but excludes elected officials and City contractors.

"Person" means any individual, entity, corporation, partnership, firm, association, union, trust, estate, as well as any parent or subsidiary of any of the foregoing, whether or not operated for profit.

"Relative" means a person who is related to the person completing this document as spouse or domestic partner, or as any of the following, whether by blood or by adoption: parent, child, brother or sister, aunt or uncle, niece or nephew, grandparent, grandchild, father-in-law, mother-in-law, son-in-law, daughter-in-law, sister-in-law, brother-in-law, stepfather or stepmother, stepson or stepdaughter, stepbrother or stepsister, half-brother or half-sister.

"Interest in any firm" means any ownership or beneficial interest in any firm, whether direct or indirect, and any other financial or economic interest in any hired trucks or equipment doing business with the City of Chicago.

5. I understand and affirm that (i) I am not debarred from or otherwise ineligible to do business with the City of Chicago and (ii) I will not sell or otherwise transfer the property I have purchased to any person who is debarred or otherwise ineligible to do business with the City of Chicago.

I understand that if I dispose of the above-captioned vehicle(s) or equipment by sale, lease, or by any other type of transfer to any firm or to any person with an interest, as defined above, or any person or firm engaged in leasing equipment to or operating equipment for the City of Chicago, I will inform that firm or person that the above-captioned equipment must not be used in connection with any City of Chicago contract.
7. I understand that some or all of the information provided in this document may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this document, I waive and release any possible rights or claims which I may have against the City in connection with the public release of information contained in this document and also authorize the City to verify the accuracy of any information submitted in this document.
8. I understand that by signing this document my signature will be kept on file and may be compared with City of Chicago vehicle and equipment reports, inventory or other documents.
